The carbon emission reduction achieved by Rocamed France through the virtual office and public transport policy have enabled a 0% emission since 2023.

Further Carbon Reduction Initiatives

In future, we will continue to implement measures to reduce carbon emissions such as:

- Evaluation of alternative energy and fuel sources to power our delivery vehicles e.g. biofuels, solar energy
- Push our delivery partner for ISO 14001 certification
- To increase delivery size and reduce number of deliveries to third party warehouse.
- Measurement of all relevant Scope 3 carbon emissions sources
- Engaging with our supply chain partners to review their approaches to carbon reduction and sustainability and to develop reduction targets for Scope 3 carbon emissions
- Introduction of EcoVadis Supplier Management Platform Suite to enable the sustainability assessment of suppliers, reporting on supplier ESG risks with a view to engaging suppliers and supporting them with identification of areas for sustainability improvement

Declaration and Sign Off

This Carbon Reduction Plan has been completed in accordance with PPN 06/21 and associated guidance and reporting standard for Carbon Reduction Plans.

Emissions have been reported and recorded in accordance with the published reporting standard for Carbon Reduction Plans and the GHG Reporting Protocol corporate standard¹ and uses the appropriate Government emission conversion factors for greenhouse gas company reporting².
